INTRODUCTION

A request has been received to meet with the Chair of Bishop's Lodge Management Committee Kerry Aldred on site at 12.30pm on Tuesday 19th March 2013.

COMMENTARY

Council has had considerable dialogue with the Committee in recent times and most issues have been resolved to some extent. The main concern now relates to the parking area in Roset Street. Several alternatives have been investigated and will be tabled at the meeting for consideration. All options require an allocation of considerable funding and Council should only consider such items in conjunction with its Delivery Plan in May/June.

Council provides the sum of \$41,000 per annum for upkeep of the Lodge and has provided a one-off additional allocation of \$57,000 for this year to replace all guttering, downpipes and drainage.

Dear Mr Dwyer,

We are writing in regards to;

- (1) Storage facilities of our Gymnastics equipment - We can no longer afford the rent at the premises and we will not have a full operational/qualified coach until later in the year.
- (2) The committee is looking at hopefully about mid year, to seek a new premises in which to operate the Hay Gymnastics Club. Our current venue (Rear of 77-79 Lachlan St) is inadequate and no longer viable to run our gymnasium and its programs efficiently.

Our current premises has major occupational health issues and the committee has decided we can no longer operate from this premises. We are also struggling financially as we have just paid 3 months rent with the premises not used at all. Due to this issue, we are hoping to move our equipment on the weekend 23 March 2013, if Council has somewhere we can store it.

The Hay Gymnastics Club has a long history of supporting the recreational and sporting pursuits of this community and its surrounds through its quality programs. We are

therefore seeking your assistance in locating more suitable premises in which to carry forward our club into the future.

We would very much appreciate your help regarding this urgent matter.

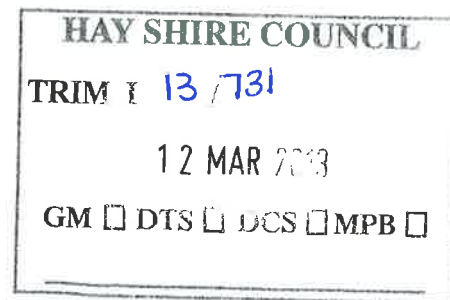
